### **PIWIK COOKIES**

It is valid for 6 months. **pk\_cvar**: This optional cookie is placed on your computer when, for example, you participate in a survey. The cookie prevents you from being asked to participate in the same survey a second time. This cookie is valid for 2 years. **\_pk\_id**: This cookie determines if you are a new or returning visitor. This cookie is valid for 2 years. **\_pk\_ses**: Same cookie determines which pages you have visited on HORIZONOFFSHORESERVICES.COM. The cookie is only valid during that specific visit.
